

The Sayles Homestead, a piece of property of over 170 acres and spanning the town line between Glocester and Burrillville Rhode Island, was established in 1760 under the ownership of Israel Sayles, great-great-grandchild of Roger and Mary Williams.



n 1880 Sylvester Sayles owned the homestead and ran a boarding house on the property. Catherine Butler, a divorcee, and her daughter Elizabeth "Lizzie" Butler came to work at the boarding house. Soon thereafter Syvlester adopted Elizabeth. Upon his death in 1901, Sylvester (pictured here) left the homestead to Lizzie.




Clockwise from top: Original farmhouse, Sayles Homestead cornerstone, 1870s map of the Pascoag Reservoir, Main House in 1950.

"While we don't know all the details, I am struck by two things: that Sylvester would adopt a young Elizabeth Sayles and leave his whole property to her, and that Judge Harris had a heart for helping troubled adolescents through his work. It indicates to me the value of caring for young people - particularly those who need a new sense of home - is part of the very soil of this homestead. I would not be the least bit surprised if the spirit that has always permeated ECC has simply been borrowed from its ancestors."

James Harris was born in Burrillville in 1860. As an adult he served as a judge in the 9th District Court in RI. Sometime in the early 1900s he came to stay at the Sayles Homestead, where he met Elizbeth Sayles. The two were later married. Judge Harris was known for his care of adolescents who came before him in court.

Elizabeth died in a nursing home in 1930, where The Rev. Dr. C. Lennart Carlson served as chaplain. Dr. Carlson introduced Judge Harris to Canon Anthony Parshley, Archdeacon of the Diocese of Rhode Island, and an arrangement was made for the judge to leave the property to the Diocese of RI to be used for youth programming or as respite for the elderly.



In the fall of 1949, Canon Parshley brought a group of young people to Pascoag to start working on the property. Two of the counselors that weekend were Patricia Cook and Leila Nichols. Part of the weekend included planning the work camp that would take place in the summer of 1950: The First Senior Work Camp.
